ATTRIBUTES



Möbius loop

The recycling symbol (or Möbius loop) indicates that a product or packaging is recyclable, contains recycled content, or both. When used to show that a product or packaging contains recycled content, the percentage of recycled content should appear, either inside or next to the symbol. When a Möbius loop is used to indicate a product is both recyclable and contains recycled content, there must be an explanatory statement supporting both claims.



PERMANENT

Permanent paper

Alkaline or neutral paper that resists aging for more than 100 years under normal warehousing conditions (criteria and certifications established by the American National Standards Institute—ANSI).

ECF

Elemental Chlorine Free

ECF is a technique that uses chlorine dioxide for the bleaching of wood pulp (virgin fiber). It does not use elemental chlorine gas during the bleaching process and prevents the formation of dioxins and dioxin-like compounds, carcinogens.

PCF

Process chlorine free

Recycled fiber manufactured with a chlorine-free process. Once the fiber has been de-inked, it is bleached with hydrogen peroxide, a chlorine-free process (PCF - Processed Chlorine Free). Hydrogen peroxide is the bleaching agent that generates the fewest environmentally harmful compounds, as the reaction produces mainly water.

FSC® Recycled

FSC® Recycled labels identify products which are made with 100% recycled fiber.

FSC® Mix sources

Certifies the product comes from well-managed forests, controlled sources and/or recycled fiber.
